The nominated person should be the sole contact for riders with the office or ground officials. Riders staying on site overnight at Worrigee Equestrian Common should be accompanied by a parent or care-giver. Any adult who is not a parent and who may be supervising competitors overnight must provide the office with a signed **Prohibited Employment Declaration** form (also attached to this schedule). **No fires** may be lit on the grounds.

## SUMMARY OF NSW RULES FOR INTERSCHOOL COMPETITION

1. **It is the responsibility of each rider to know the rules for competition.**
2. A judge or other official may request a rider change divisions in a hacking or show jumping event where this combination is considered unsuitable for the division in which entered.
3. A judge has the right to eliminate a rider for the incorrect use of gear in any discipline.
4. An unsafe combination, or unsound horse or rider with unsafe gear may be referred to the office. Such cases will be reviewed by the *Event Committee, whose decision is final.*
5. *A first aid centre* and/or paramedic will be available on all days at the clubhouse.
6. Any rider falling from a horse on either day of competition will be checked by medical staff and may not be permitted to ride again that day.
7. No rider may compete with stirrup leathers under the saddle flap or tied to any part of the saddle.
8. All horses must be ridden at a walk when not in a nominated practice or competition area

### **Uniform:**

1. A long-sleeved school shirt, school jumper, tie, saddlecloth & EA compliant safety helmet and boots. School sport sloppy-joe / jumper / t-shirt may be worn in events other than hacking and dressage.
2. Riders are to display their given rider number on the near side of the saddlecloth.

### **General:**

1. **Welfare of the horse is paramount.**
2. Unsportsmanlike behaviour will not be tolerated.
3. All Judges' decisions must be respected, but queries may be made in writing to the Event Committee.
4. The Event Committee (comprising representatives from NSW and the host club) will determine all queries and their decision is final.
5. Any rider who does not abide by NSW and/or his/her School's Code of Conduct may be reported to the Management Committee and may be disqualified from further competition.
6. Riders, their parents and other connections are expected to treat all officials and fellow competitors with respect and assist where possible in the smooth, happy running of the competition. In the case of failure to show respect, the rider, their parents and other connections will be required to leave the grounds for the remainder of the competition by order of the organising committee.

## LOCAL RULES

### **Horses:**

1. Riders may only compete on one horse over the three days. In the case of lameness a substitute horse may be brought and the team manager should advise the office in writing.
2. A rider may only ride his or her horse in a maximum of three rounds of jumping on any one day.
3. Only the nominated rider may ride/school the horse at the venue but a horse may be lunged by someone other than the rider. Failure to abide by this rule will mean disqualification of the horse from the rest of the event.
4. Led riders both mounted and unmounted must be under the supervision of a responsible adult at all times.

### **Draw and Interpretation:**

1. The draw /s and other information pertaining to this Championship will be posted on the Berry Riding Club website.
2. A rider wishing to change section or times in any draw, must advise the organisers in writing as soon as possible and before the day starts.
3. Workouts for Hunter, Horsemanship and Challenge classes will be posted on the Notice Board at the clubhouse.
4. Interschool Challenge: Riders should read the Rules on the Equestrian (NSW) website. This competition is run in divisions of 'No Jumping' and 'Jumping' (two height options offered).

### **Other:**

1. Camping is allowed on the Clubhouse level as well as amongst the trees. Horse-free parking is available at rear of clubhouse. Vehicles without a float should be parked behind the clubhouse overnight to avoid paying an additional \$20 camping fee.
2. Powered sites and yards are not available for day stay competitors. All power cords are to have an electrician's approved tag attached. Power points are limited. Power will be allocated in order of receipt of entry forms. Only riders who have paid for power will be allowed to park near the power outlets. It is best to bring your own generator if possible.
3. Yards booked will be allocated prior to the competition and emailed to competitors.
4. Any temporary yard erected must be constructed of metal. No rope or tape yards may be used at any time.
5. Wash bays are available near the horse yards (bring your own hose & attachment).

### DRESSAGE – SATURDAY

Riders may enter only one horse in flatwork on the day. Riders must choose to compete in either Dressage or Hacking, not both. A horse may compete in three different tests over two consecutive levels. Gloves are to be worn. First test may start at 8am. Riders must report at their allotted time as per the draw.

The time draw will be displayed on the Berry Riding Club website.

### HACKING – SATURDAY

Hacking will be run in Divisions. Start time 9:00am in all rings except the Beginner/Led ring. This ring will start at 10:00am. Riders may enter only in hacking or dressage. Riders must compete in their nominated Division all day except in a case where the judge requests a competitor be moved up/down in the interest of safety or fairness.

**Open (Division 1):** - rider/horse combinations competing regularly at agricultural shows, royal shows and HOTA shows.

**Intermediate (Division 2):** - rider/horse combinations who compete regularly at agricultural shows and zone pony club gymkhanas but have not competed in similar events at a royal show or HOTA.

**Novice (Division 3):** - rider/horse combinations who have not placed regularly at agricultural shows or zone pony club gymkhanas in similar events. Must be able to walk, trot and canter in a controlled manner. Horse must be shown with a single rein bridle.

**Beginner (Division 4):** - these classes will be conducted at walk/trot (no cantering). Beginner Rider only applies to the hacking classes on Saturday. These riders are not so restricted on Sunday or Monday.

**Led Rider (Division 5):** – these riders must be supervised by a responsible adult at all times.

Within each division classes will be divided as appropriate into Height Classes in which the horse is the primary focus of judging and into School Year Classes where the rider is the primary focus.

Classes will be equal in numbers where possible. This will be determined after the close of entries and published on the website. Primary and Secondary riders will be judged in separate sections for each of hacking and riding classes where points are given.

# SUNDAY, 30<sup>th</sup> September 2018

## SHOWJUMPING – SUNDAY

*Riders need to be competent at the nominated height.* Judges reserve the right to withdraw a combination deemed to be unsafe at the nominated height. Course Walk for the first competition of the day will be 7:30am.

- Maximum heights are for first round of the day only at each height class but will not exceed 15cm above that stated for subsequent classes.
- The height classes will be 45cm, 60cm, 75cm, 90cm, 1.05m. Note that 45cm is restricted to Primary competitors only. 45cm riders are restricted to two classes only.
- No optimum time.
- Horses may compete in a maximum of three competition rounds in heights other than 45cm. No two rounds should be in the same event and at the same height. Show jumping rounds must be of the same or consecutive levels.

### Fault & Out

#### Super Phase (Power & Speed)

#### Immediate Jump off competition (AM7)

### FAULT-AND-OUT COMPETITION (Article 266)

This competition takes place against the clock over a course without any combination obstacles. The round finishes at the first fault committed (obstacle knocked down, any disobedience, fall etc) or when the rider has jumped the last obstacle at which point the time is taken. Points are awarded with 2 points for an obstacle jumped correctly and 1 point for an obstacle knocked down. The winner of the competition is the athlete who obtains the greatest number of points. In the event of equality, the rider with the fastest time will be declared the winner. In the event of equality of points and time for first place only, there will be a Fault-and-Out jump-off over a limited number of obstacles. Note that when an obstacle is knocked down or when the fixed time is reached, the bell is rung. The rider must then jump the next obstacle but no points are given for this.

### SUPER PHASE COMPETITION (Art 274)

Two phases run without interruption with the finishing phase for the first phase being the starting line for the second phase. Athletes penalised in the first phase continue on carrying their penalties from the first round. The second phase only will be timed and penalties accumulated as 1 for every 4 commenced seconds after the time allowed for this round.

### AM7 IMMEDIATE JUMP OFF COMPETITION (Art 245.3)

Athletes who have completed their preliminary round without penalties must proceed to the jump-off without leaving the arena. The bell will be rung again to signal the athlete to start the jump-off course. The 45 second count-down applies.

## SPORTING – SUNDAY

Ribbons will be awarded in each of the school year groups. All events will be timed for individual placings for each year. The fastest times for both Primary and Secondary for each competition will also be rewarded with a rosette.

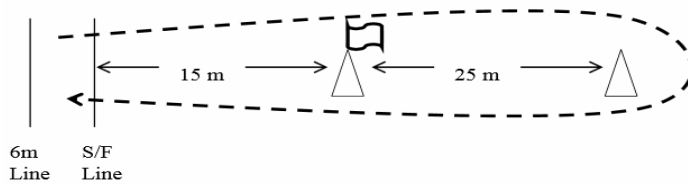

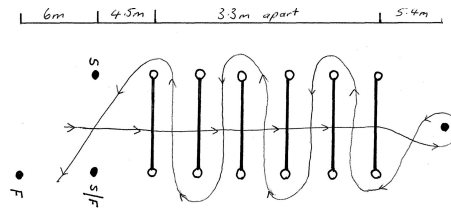

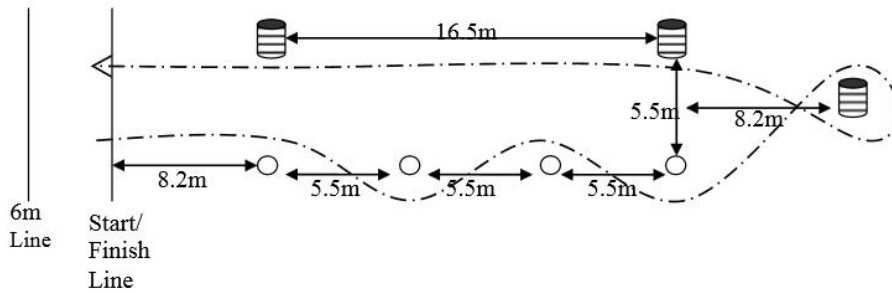
**One Flag Race** - The riders will start with a flag in their hand and ride to the first road cone and place the flag in it. They then ride around the marker at the end of the arena, and pick up the flag from the road cone on the way back to the finish line. If a rider drops a flag they can dismount, but must place the flag in the road cone from the mounted position.



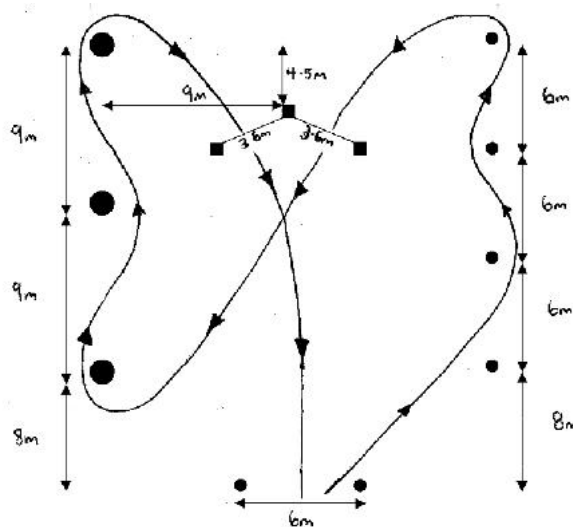
**Snakes & Ladders** - The rider will ride down a set of small jumps around the top peg then proceed back to the finish line by weaving in and out of the small jumps. The finish line will be located at 90 degrees to the starting line. Failure to ride through the finish line will mean elimination. Elimination will also occur if a hurdle is knocked down, horse runs out of the course 3 times, bypasses a hurdle and does not retake it or spreads any two or more hurdles & fall of horse or rider.



**Bend Bar Aft** - the rider bends through poles, circles a barrel then picks up a flag, then exchanges it for another flag, races to the finish lines with the flag.



**Scudahoe** - Rider goes to right and bends through the 4 poles, jumps a rail and then bends around the 3 drums, jumping the other rail before finishing.



**Double Slalom** - Rider leaves bending poles to his right and gallops to last pole, turns and weaves through 2 sets of poles and back to the finish line. The poles are set 6m apart on both sides. A diagram of the Double Slalom will be displayed on the scoreboard.

## INTERSCHOOL CHALLENGE – MONDAY

This competition aims to promote rider development and provide a basis from which riders can move into other disciplines. The Challenge is run as a two phase (non-jumping) or three phase (jumping) competition. A draw for the jumping phase will be published prior to this event. Failure to compete at the allocated time or failure to present to the judge when called will result in elimination. There will be no draw for the Ridden & In Hand Phases. Riders must complete these phases prior to 12:00 noon.

### General Conditions:

- Spurs are allowed. Whip must not exceed 75cm and may be carried in all phases.
- Only snaffle bridles with hanoverian, flash, drop or cavesson nosebands are permitted.
- Martingales, bearing, side or running reins of any kind are NOT permitted.
- Same saddlery must be used for all phases.
- Back protectors, tendon boots may be added for the jumping phase.
- Numbers should be on bridles for in hand phase.
- Riders may compete in short or long boots.
- Each horse and rider combination must complete all phases to obtain a score.
- The phases each have an equal weighting.

### Phase 1: Individual Ridden Display.

To be judged on rider's position, aids and ability to present the horse as well as on the horse's way of going.

### Phase 2: Jumping

To be judged as a working hunter competition.

### Phase 3: In Hand Presentation (completed after phases 1 and 2).

Competitors will present the horse in hand with saddles not removed. Riders must ride into the ring, dismount and proceed to the judge to commence their In Hand Presentation.

### Attitude & Conduct marks

True showmen behave with dignity in the ring and understand that they are on show at every moment. Competitors begin each phase with a maximum of 10 marks for attitude and conduct. By simply behaving in a respectful and cooperative manner, all competitors should retain their maximum of 10 marks.

---

## HUNTER COMPETITION – MONDAY

*This event is not for beginners. Horses are expected to be able to jump their nominated height competently and at speed. A draw will be published on the Berry Riding Club website.*

This class is judged on the rider and the horse as a hunter. It is marked with points in a manner similar to Jumping Equitation. All tack and clothing is to be neat and workmanlike. Decorations, bright colours and artificial aids are not appropriate. Severe bits and aids may be penalized but should be used only if required for safety reasons. EA compliant helmets and appropriate footwear must be worn. Riders will be required to ride a simple workout on the flat then, without stopping, proceed in a more forward canter and jump 8 fences, consisting of both show jumps and solid x/country fences. The course will have no combinations. The two judges will mark concurrently:

**Rider on the flat** – judged on the rider's ability to ride in rhythm on the flat at various gaits, at an appropriate speed with the correct use of 2-and 3-point seats.

**Rider over fences** – judged on the rider's ability to negotiate fences at an appropriate safe speed, in rhythm and in the control when hunting or riding cross country.

**Hunter on the flat** – judged on the horse, which should be obedient and easy to handle, work at a relaxed trot through to a gallop in hand with complete control.

**Hunter over fences** – judged on the horse's ability to negotiate a course of fences in the most pleasurable, smoothest and eye-pleasing manner.

**Primary Riders** 60/65cm or 75/80cm

**Secondary Riders**

60/65cm or 75/80cm

---

## GAMBLERS' STAKES COMPETITION – MONDAY

This fun competition will be run while the point score is being finalised and doesn't feed to the point scores. It involves a top score jumping competition where riders choose which course they will ride in order to gain the highest score. The top height course will be set first and lower courses will be set until we have winners for the nominated class groups. Each course offers 11 obstacles of different heights and the competitor must clear no more than 7 jumps within the allowed time passing through the start/finish line at commencement and completion of his seven jumps or on the bell denoting time finished. In the event of an equality of points accrued, the competitor with the fastest time is declared the winner.

# PROHIBITED EMPLOYMENT DECLARATION

## CHILD PROTECTION (PROHIBITED EMPLOYMENT) ACT 1998

The Child Protection (Prohibited Employment) Act 1998 makes it an offence for a person convicted of a serious sex offence (a Prohibited Person) or a Registrable Person under the Child Protection (Offenders Registration) Act 2000, to apply for, undertake or remain in, child-related employment. It does not apply if an order, from the Industrial Relations Commission or the Administrative Decisions Tribunal or the Commission for Children and Young People, declares that the Act does not apply to a person in respect of a specific offence.

Section 5 of the Child Protection (Prohibited Employment) Act 1998 defines involving sexual activity or acts of indecency that was committed in NSW and that was punishable by penal servitude or imprisonment for 12 months or more, even if the sentence was not served; or

- An offence involving sexual activity or acts of indecency that was seen commit punishable by penal servitude or imprisonment for 12 months or more if it had been committed in NSW; or
- an offence under Sections-91G (other than committed by a child prostitute) and 578B or 578C(2A) of the Crimes Act 1900 or a similar offence under a law other than a law of NSW; or
- an offence of attempting, or of conspiracy or incitement, to commit and of paragraphs; or
- any other offence prescribed by the regulations.

Note: A conviction for carnal knowledge is classified as a serious sex offence under this legislation. Child-related employment means any employment, where at least one of the essential duties of the position, involves direct contact with children where that contact is not directly supervised. Section 3 of the Child Protection (Prohibited Employment) Act 1998 specifies that child-related employment is employment:

- involving the provision of child protection services;
- in pre-schools kindergartens and child care centres (including residential child care centers);
- in schools or other educational institutions (not including universities)
- in detention centres (within the meaning of the Children Detention Centre)
- in refuges used by children
- in clubs, associations or movements (including of a cultural, recreational child membership;
- in any religious organisation; • in any entertainment is primarily venues children, whether a babysitter or childminder that is arranged by a commercial agency; • involving regular provision of taxi services for the transportation of children; • involving the direct provision of health services; • involve in support services for children; • on school buses;
- at overnight camps for children;
- any other prescribed by regulation.

Under this Act:

- it is an offence for a Prohibited Person to apply-related for, employment; undertake or remain
- employers must ask existing employees, both paid and unpaid, and prefer declare if they are a Prohibited Person or not;
- all – related child employees must inform their employers if they are a Prohibited Person or remove themselves

from child-related employment. A Prohibited Person is someone who has been convicted of a serious sexual offence or, who has had a finding for a charge of a serious sexual offence proven in court, even if a conviction was not recorded;

- penalties are imposed for non compliance.

I am aware that I am ineligible to apply for, undertake or remain in, child-related employment if I have been convicted of a serious sex offence as defined in the Child Protection (Prohibited Employment) Act 1998 or if I am a Registrable Person under the Child Protection (Offenders Registration) Act 2000.

I have read and understood the above information in relation to the Child Protection (Prohibited Employment) Act 1998. I am aware that it is an offence to make a false statement on this form.

I declare that I am not a person prohibited by the Act from seeking, undertaking or remaining in child-related employment. I understand that this information may be referred to the Commission for Children and Young People and/or to NSW Police for law enforcement purposes and for monitoring and auditing compliance with the procedures and standards for employment screening in accordance with Section 36 (1) (f) of the Commission for Children and Young People Act 1998.
